Changes in VAT calculation and customer implications

Adjustments in the VAT calculation of acceptance fees

The VAT calculation logic is adapted to international standards and has implications for the presentation in the Concardis portal and the individual transaction reports

It will therefore no longer be possible to show VAT and the amount paid out at individual transaction level. This has implications for the following itemized statements:

Changes in EPA (Electronic Payment Advice)

EPA will be offered exclusively in the latest EPA-6FX (net)/ EPA-GBX (gross) format in the future. The new VAT calculation logic also entails changes in content. Since VAT is now calculated at batch level instead of individual transaction level, no VAT will be shown in the 610/611 record (individual transaction level)
